Kelly Boyd is Senior Research Fellow at the Institute of Historical Research, School of Advanced Study, University of London. In addition to her monograph, *Manliness and the Boys' Story Paper in Britain: A Cultural History*, 1855–1940 (Palgrave Macmillan 2003), she has written on the

early history of television in Britain, issues of Americanization, and masculinity, most recently in *Media History*. With Rohan McWilliam, she edited *The Victorian Studies Reader* (Routledge, 2007). From 2004–10, she served as Treasurer of the Social History Society of the UK and is currently reviews editor of *Cultural and Social History*.

Mark J. Crowley is Associate Professor and Early Career Hubei Provincial 'Chu Tian' Scholar at Wuhan University, China. He has published numerous articles on nineteenth-century British Trade Unionism, Welsh Nationalism, Devolution in Wales, and women's employment in World War II. He is currently completing a monograph on women's employment in the British Post Office during World War II, and is editing (with Sandra Dawson) a volume on the Home Front in Britain and the Empire during World War II.

Paul R. Deslandes in an Associate Professor and Chair of the Department of History at the University of Vermont, where he has taught since 2004. He is the author of Oxbridge Men: British Masculinity and the Undergraduate Experience, 1850–1920 (Indiana University Press, 2005) as well as a variety of articles and essays on the history of British education, masculinity, sexuality and the history of the body. He is currently completing a new book titled The Culture of Male Beauty in Britain: From the First Photographs to David Beckham.

His current research explores French experience with economic controls, black markets and consumption during and after World War II, with recent articles in French History, French Historical Studies and The Journal of Contemporary History.

Bianca Murillo is Assistant Professor of History at Willamette University in Salem, Oregon. Her research and teaching interests include modern Africa, the history of global capitalism, comparative consumer cultures, and critical race and gender studies. Her research has been published in *Africa*, *Enterprise & Society* and *Gender & History*, and she is a recent recipient of the prestigious 2013–14 Woodrow Wilson Career Enhancement Fellowship.
