MEDICINE: GEMS PROVIDES SUPPORT FOR MEDICAL EDUCATION, RESEARCH AND THE DELIVERY OF MUCH-NEEDED MEDICAL SERVICES AND SUPPLIES IN THE DEVELOPING WORLD. THEY SENT 11 STUDENTS FROM SOUTH SUDAN (AFTER TESTING THEM TO DETERMINE WHO WAS BEST) TO ST. GEORGE'S UNIVERSITY IN GRENADA W.I., TO STUDY PRE-MED. THERE ARE 41 DOCTORS IN SOUTH SUDAN WHO LIVE THERE AND 10.2 MILLION PEOPLE. ST. GEORGE'S PAYS THEIR ENTIRE FEES/LIVING AND EXPENSES AND GEMS PAYS THEIR TRANSPORTATION TO AND FROM SOUTH SUDAN AND AS STIPEND TO THEIR FAMILIES IN SOUTH SUDAN AS THEY ARE NOT THERE TO PROVIDE FOR THEIR FAMILY. OTHER KEY ACCOMPLISHMENTS: *PAID FOR TRAVEL FOR DOCTORS AND NURSES TO TEACH AND ADMINISTER TREATMENT TO PEOPLE IN THE BUSH-- AWEIL AND RURAL PARTS OF NORTHERN BAHR EL GHAZAL.

ONE GOAT OPENS A WORLD OF SURVIVAL AND ALLOWS A FAMILY TO HAVE THE SAFETY NET TO PURSUE EDUCATION AND MICRO-BUSINESS. NEIGHBOURS CAN WORK TOGETHER TO START SMALL LOCAL DAIRIES, CREATING SUSTAINABLE BUSINESSES AND BREAKING THE CYCLE OF HUNGER AND EXTREME POVERTY. THE ORGANIZATION HAS GIVEN OUT 4000 GOATS TO RETURNING SLAVES AND INDENTURED SERVANTS FROM THE NORTH, AS WELL AS TO HUNGRY FAMILIES AND TEACHERS WITHIN TWENTY-FIVE MILES OF THE BORDER OF THAT AREA.

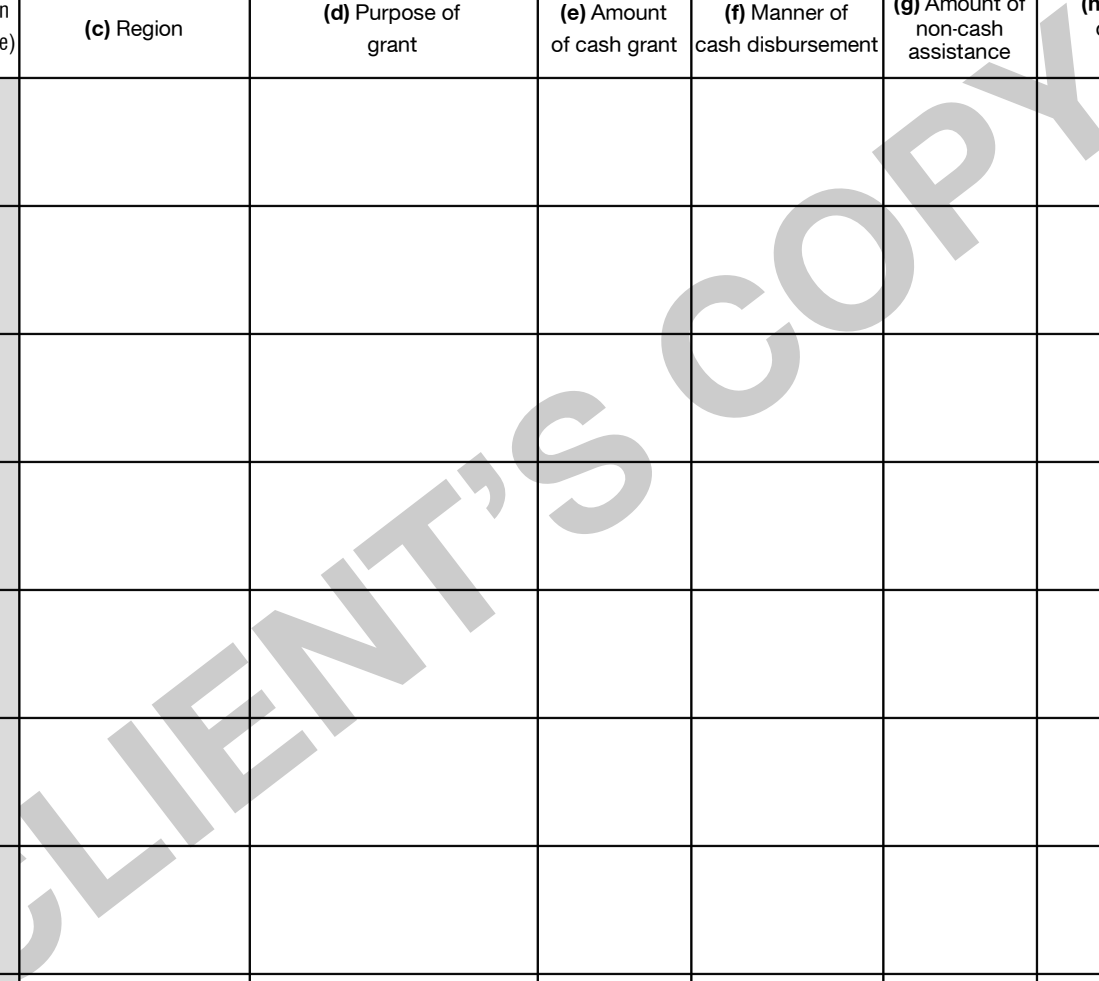

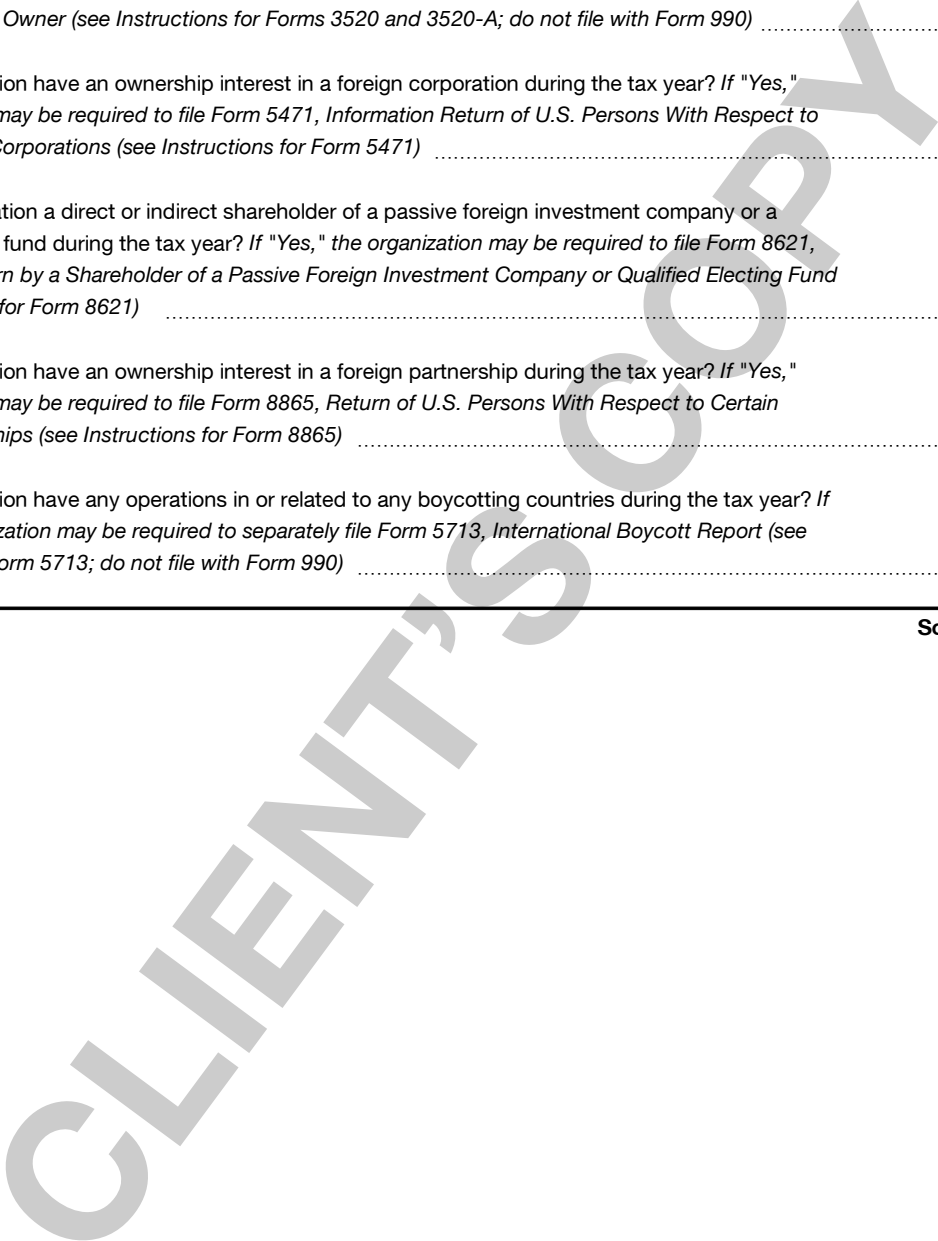
